

Certificate IV in Training & Assessment (TAE40122) for Dance Teachers

This program is offered by Blueprint Career Development (RTO # 30978) and here's an outline of their TAE40122 program that has been custom designed to acknowledge the skills & knowledge already held by practicing dance teachers and others from the creative industries.

The TAE40122 qualification requires the completion of the 12 topics (units of competency) and involves a combination of:

- Pre-reading of learning materials and completion of 'warm-up' activities
- Attendance of 5 Zoom* days of workshop to complete the practical project work
- · Homework at night or after workshop to complete repeat project work & knowledge Qs
- Recognition of Prior Learning (RPL) evidence related to planning, organising & delivering training
 *Face to face workshop can be run at your location if you have a group of 10+ participants



Cost

Face to face classroom program is \$1990pp

A credit transfer cost reduction may apply if TAE40122 units already held
